RESOLUTION NO. 58

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A CONTRACT OR AGREEMENT WITH THE YAKAL CONSTRUCTION FOR THE CONSTRUCTION OF ONE (1) UNIT DEEP WELL AT BRGY. BAGONG BUHAY, ORMOC CITY.

WHEREAS, Resolution No. 49 s. 1991 adopting Appropriation Ordinance No. 91-15 has authorized a budgetary appropriation for the construction of one (1) unit Deep Well at Brgy. Bagong Buhay, this city, said deep well is alleged to be the new source of rural waterworks project;

WHEREAS, the Pre-Qualification Bidding and Awards Committee (PBAC) had conducted a public bidding for the construction of said deep well at Brgy. Bagong Buhay and, three (3) prospective contractors had submitted their corresponding bids as follows:

1) MAC BUILDERS	- P 281,981.25
2) D. MORALES ENG'G. WORKS	- 284,625.00
3) YAKAL CONSTRUCTION	- 252,812.50,

and, after evaluation, the PBAC through its Resolution No. 1 s. 1991 has awarded the project to Yakal Construction, represented by its proprietor, Engr. Violeta Codilla;

WHEREAS, in accordance with existing policies, it is necessary that a resolution be made to the effect authorizing Her Honor, the City Mayor, to sign in behalf of the City Government, a contract for said deep well construction with Yakal Construction, the lowest bidding contractor;
