A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 92 S. 1991 OF THE SANGGUNIANG PANLUNGSOD NG BAGUIO, BAGUIO CITY, REQUESTING AMENDMENT OF CIRCULAR NO. 38 S. 1990 OF THE JOINT COMMISSION ON LOCAL GOVERNMENT PERSONNEL ADMINISTRATION ON TRAVEL (DOMESTIC) ALLOWANCES.

WHEREAS, this august Body is in receipt of Resolution No. 92 s. 1991 of the Sangguniang Panlungsod ng Baguio, Baguio City, "requesting Amendment of Circular No. 38 dated 2 October 1990 of the Joint Commission on Local Government Personnel Administration on Travel (Domestic) Allowances";

WHEREAS, the said resolution has questioned the reasonableness of the rates of the daily travelling allowances correspondingly allowable to local government officials and employees on official domestic travel, as set forth in Section 2.2 of Circular No. 38 of the Joint Commission;

WHEREAS, the Sangguniang Panlungsod ng Ormoc is with a modest belief that the afore-questioned rates of travelling allowances are indeed unconscionably low, hence conforms to the propriety and embodiment of Resolution No. 92 as passed by the local legislative body of Baguio City;
