## RESOLUTION NO. 65

REQUESTING THE PHILIPPINE PORTS AUTHORITY A RESOLUTION EARMESTLY (PPA) FOR THE CONSTRUCTION OF A 50-METER EXTENSION OF THE ORMOC CITY PIER.

WHEREAS, Ormoc City, on steady progress in the last decade and fast becoming the focal point of entry and departure of businessmen and travellers to and from neighboring and far-flung cities and provinces, needs an accommodative or more spacious Ormoc City Pier;

WHEREAS, the existing city pier, as characterized by the passage of years from when it was constructed in 1934, is fast becoming an obsolete vintage - short and narrow - which could hardly accommodate the heavy filings and flow of cargoes to and from docked ships, barges and other boats, -a situation which greatly endanger the security and safety of people, mostly passengers, who walk through hectic passage to and from anchored vessels;

WHEREAS, Her Honor, the City Mayor, has requested in writing the conorable Sangguniang Panlungsod through the Vice Mayor & SP Presiding Officer, for passage of a resolution requesting PPA for construction of fifty (50) meters extension of the Ormoc City Pier;

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, supportive to valid and laudable plans and projects of the Local Chief Executive, in the latter's desire for continuous
