RESOLUTION NO. 66

A RESOLUTION ENDORSING WITH FULL SUPPORT RESOLUTION NO. 57 S. 1991 OF THE SANGGUNIANG PANLUNGSOD NG DANAO, DANAO CITY, STRONGLY REQUESTING THE PHILIPPINE NATIONAL POLICE TO INCREASE THE SUBSISTENCE ALLOWANCE FOR PRISONERS THROUGHOUT THE COUNTRY.

WHEREAS, this august Body is in receipt of Resolution No. 57 s. 1991 from the Sangguniang Panlungsod ng Danao, Danao City, entitled "A Resolution strongly requesting the Philippine National Police to increase the Subsistence Allowance for Prisoners throughout the country";
