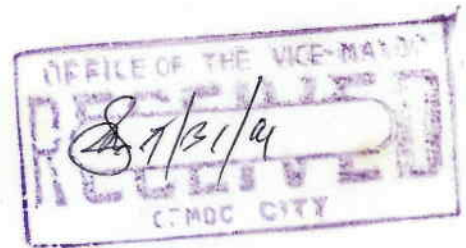

RESOLUTION NO. 73

A RESOLUTION SINCERELY THANKING THE REGIONAL EQUIPMENT ENGINEER, 8TH REGIONAL EQUIPMENT SERVICES, BUREAU OF EQUIPMENT, DPWH, PAWING, PALO, LEYTE, THROUGH ENGR. ALFONSO S. SARMEN, JR., ENGINEER IV OF SAID REGIONAL EQUIPMENT SERVICES, AND ENGR. DOMETILLO C. SILVA, AREA 5 EQUIPMENT ENGINEER, FOR THE TRANSFER WITHOUT COST OF 288 PIECES OF UNSERVICEABLE TIRES TO THE CITY GOVERNMENT OF ORMOC.

WHEREAS, this august Body has enacted Resolution No. 171 s. 1990 earnestly requesting Engr. Ramon A. Alejo, Regional Equipment Engineer, Region VIII, Tacloban City, to release at least 1,000 unserviceable tires to be used in the construction of artificial reef modules to all coastal barangays in Ormoc City;

WHEREAS, that said Regional Equipment Office through Engr. Alfonso S. Sarmen, Jr., for and in the absence of the Regional Equipment Engineer, has transmitted to Engr. Dometillo C. Silva, Area 5 Equipment Engineer, this city, the approved request for transfer without cost of 288 pcs. unserviceable tires of various sizes to the Sangguniang Panlungsod ng Ormoc, with the following proper disposal procedures to be observed before delivery is effected:

(Res. 73 S. 1991)

"1) The corresponding 288 waste material reports for each unserviceable tires must be signed by COA representative as a witness together with a representative by that Office in the space provided for;

2) The corresponding serial numbers for the 288 unserviceable tires withdrawn must be reflected in the Tally-Out Sheet to be signed by authorized persons and received by a representative of the Sangguniang Panlungsod, Ormoc City;

3) That the subject waste material reports duly accompanied be attached to this set of documents and the same be forwarded to this Office for accounting purposes".

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, has considered this action so laudable and much commendable, hence, must be accorded with due course and immediate action;

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., duly seconded by Kagawad Benjamin F. Tugonon; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to sincerely thank the Regional Equipment Engineer, 8th Regional Equipment Services, Bureau of Equipment, DPWH, Paving Palo, Leyte, through Engr. Alfonso S. Sarmen Jr., Engineer IV of said Regional Equipment Services, and Engr. Dometillo C. Silva, Area 5 Equipment Engineer, for the transfer without cost of 288 pieces Unserviceable Tires of various sizes to the City Government of Ormoc;
