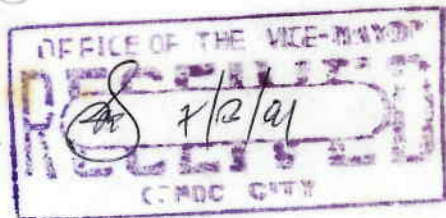

RESOLUTION NO. 75

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF ABSOLUTE SALE WITH MS. ESCOLAUSTICAL VALLE, LOT OWNER OF A PARCEL OF LAND CADASTRAL LOT NO. 2363-B-7-1, UTILIZED BY THE CITY'S ROAD-RIGHT-OF-WAY, CONTAINING AN AREA OF 1,078 SQUARE METERS, SITUATED AT BRGY. DONA FELIZA Z. MEJIA, ORMOC CITY, REPRESENTED BY HER ATTORNEY-IN-FACT DELIA L. PITOGO PURSUANT TO RESOLUTION NO. 71 S. 1991 EMBODYING APPROPRIATION ORDINANCE NO. 91-21.

WHEREAS, this august Body has enacted Resolution No. 71 s. 1991 adopting Appropriation Ordinance No. 91-21 authorizing initial payment of P50,000.00 to Ms. Escolastica Valle, registered owner of Lot No. 2363-B-7-1 with an area of 1,078 square meters, situated at Brgy. Doña Feliza Z. Mejia, this city, through her Attorney-In-Fact Delia L. Pitogo;
