ESCOLASTICAL VALLE, LOT OWNER OF A PARCEL OF LAND CADASTRAL LOT NO. 2363-B-7-1, UTILIZED BY THE CITY'S ROAD-RIGHT-OF-WAY, CONTAINING AN AREA OF 1,078 SQUARE METERS, SITUATED AT BRGY. DONA FELIZA Z. MEJIA, ORMOC CITY, REPRESENTED BY HER ATTORNEY-IN-FACT DELIA L. TO RESOLUTION NO. 71 S. 1991 PITOGO PURSUANT APPROPRIATION ORDINANCE NO. 91-21.
