A RESOLUTION REQUESTING THE HONORABLE ASSISTANT SECRETARY, DEPARTMENT OF TRANSPORTATION AND COMMUNICATIONS - LAND TRANSPORTATION OFFICE, TO FURNISH THE HONORABLE SANGGUNIANG PANLUNGSOD NG EARER OR SPECIFIC GUIDELINES RELATIVE TO WITH 89-108 S. 1989 RE: GUIDELINES IN THE R NO. 89-108 S. 1989 RE: GUIDELINGS IN R NORKIS' WONDER CABS AND THE VMC'S BAJAJS, E NORKIS' WONDER CABS AND THE MARKET AS NEW MEMORANDUM CIRCUNAR MO OR VEHICLES RE-INTRODUCED INTO THE MARKET AS NEW SHOWING NEW MODES OF TRANSPORT, MODEL: CLASSIFICATIONS AND SUB-CLASSIFICATIONS OF UNITS OF MOTOR VEHICLES COVERED AND INVOLVED, SPECIALLY THAT THE UNITS AS MENTIONED THEREOF ERTAIN TO THE NORKIS' WONDER CABS AND THE VMC'S WEELED VEHICLES. THREE-

EREAS, this august Body, through the representation of the norable Chairman, Committee on Transportation and Communications, possession of a copy of Memorandum Circular No. 89-108 dated September 1989 of the Department of Transportation & Communications -Land Transportation Office which pertains to the Guidelines in the Registration of the Norkis' Wonder Cabs said the VMC'S Bajajs, threewheeled motor vehicles re-introduced into the market as New Models or New Modes of Transportation;

WHEREAS, the aforesaid LTO Memorandum Circular has definitely affected and would continue to seriously affect the basic collection of the registration fees of existing tri-wheeler vehicles in Ormoc City an unprecendented increase of more than 200% from last registration

said existing and ordinary motorcabs, to the point that the motorcabs association in Ormoc City has protested the sharp increase of said registration fees;

WHEREAS, in the absence of more specific or clearer guidelines in this regard, this august Body is more inclined to the representations made by the Chairman and Members of the Committee on Transportation and Communications that the said Memorandum Circular at issue pertains definitely to another models or modes of transportation different to the existing tri-wheeler or ordinary motorcabs, that it pertains only to the Norki's Wonder Cabs and the VCM's Bajajs, three-wheeled tehicles:

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Milla, Jr. Chairman, Committee on Transportation and Communications, severally seconded by mga Kagawad Eufrocino C. Codilla, Jr., Arnolfo C. Salazar, Gregorio A. Yrastorza, Jr., Benjamin F. Tugonon and Nelson DL. Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to request the Assistant Secretary of the Department of Transportation and Communications — Land Transportation Office, Quezon City, to furnish the Honorable Sangguniang Panlungsod ng Ormoc with clearer or specific guidelines relative to LTO Memorandum Circular No. 89-108 s. 1989 re Guidelines in the Registration of the Norkis' Wonder Cabs abd the VCM's Bajajs, three-wheeled motor vehicles re-introduced into the market as New Models or New Modes of Transport, showing therein the classifications and sub-classifications of units of motor vehicles covered and involved, specially that the units as mentioned is said Memo-Circular only pertains to the Norkis' Wonder Cabs and the VCM's Bajajs, three-wheeled vehicles;

RESOLVED, FURTHER, to request the Land Transportation Office (LTO) this city, registrations of tri-wheeler motorcabs in Ormoc City under the provisions of LTO Memorandum Circular No. 89-108 s. 1989, however, to be noted "DNDER PROTEST", pending response from the Honorable Assistant Secretary, Department of Transportation & Communications, Quezon City, to Resolution No. 79 s. 1991, -this resolution of the august Nooy:
