RESOLUTION NO. 82

A RESOLUTION OF CONDOLENCE TO THE BEREAVED FAMILY AND CLAN OF THE LATE KAGAWAD CRISTOBAL S. MENDOLA OF THE HONORABLE FIRST AND SECOND SANGGUNIANG PANLUNGSOD NG ORMOC.

WHEREAS, this august Body bears the shock with which it takes the news of the death of a highly esteemed former Kagawad CRISTOBAL S. MENDOLA of the Second Sangguniang Panlungsod ng Ormoc who succumbed in the evening last July 5, 1991;

WHEREAS, the late Atty. CRISTOAL S. MENDOLA, a bonafide resident of Ormoc City, had dedicated the best years of his life to the Ormocanons for whose common weal had been his primodial concern, a hard-working man whose sole aim was to serve his fellowmen; "TOBAL", as he was fondly called by everybody in Ormoc, had greatly helped bring Ormoc to its present status of a financially stable, peaceful and beautiful city;

WHEREAS, reckoning back to his service in the government of which he had served for sixteen (16) years and two (2) months, he was first appointed as a Technical Assistant in the Office of the City Mayor from December 1, 1965 to August 30, 1967; elected City Councilor from January 1, 1972 to December 31, 1975; appointed Kagawad of the First Sangguniang Panlungsod ng Ormoc from January 10, 1976 to January 3, 1980, and subsequently, elected Kagawad of the Second Sangguniang Panlungsod from March 3, 1980 to May 15, 1986;
