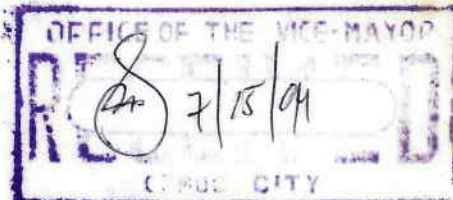

RESOLUTION NO. 83

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A FINANCIAL AGREEMENT RELATIVE TO THE PROCUREMENT OF A BANTAY DAGAT PATROL BOAT WITH THE NATIONAL AGRICULTURAL AND FISHERY COUNCIL (NAFC).

WHEREAS, this august Body is in receipt of a letter dated 9 July 1991 from Mr. Augusto T. Pongos, Chairman, Provincial Agricultural and Fishery Council, Ormoc City, addressed Her Honor, the City Mayor of Ormoc, requesting for passage of the following documents: a) authorization of the person to sign the Financial Agreement and b) for the person authorized to receive the check for the Bantay Dagat patrol boat funding, -all addressed to the National Agricultural and Fishery Council (or NAFC), as required papers in connection with the application for the procurement of a Bantay Dagat patrol boat;

WHEREAS, the aforecited letter has further stated that processing of the application for the Bantay Dagat patrol boat is delayed most probably due to the absence of the aforementioned documents, particularly that of the "authorization of the person to sign the Financial Agreement with NAFC";

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., duly seconded by Kagawad Nelson DL. Geneston; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A FINANCIAL AGREEMENT RELATIVE TO THE PROCUREMENT OF A BANTAY DAGAT PATROL BOAT WITH THE NATIONAL AGRICULTURAL AND FISHERY COUNCIL (NAFC);


