RESOLUTION NO. 84

A RESOLUTION AUTHORIZING THE CITY TREASURER OF ORMOC TO RECEIVE THE MONEY OR CHECK WORTH P54,000.00 FOR THE FUNDING OF BANTAY DAGAT PATROL BOAT FROM THE NATIONAL AGRICULTURAL AND FISHERY COUNCIL (NAFC).

WHEREAS, Mr. Augusto T. Pongos, Chairman, Provincial Agricultural and Fishery Council, a Non-Governmental Organization (NGO) based in Ormoc City, has informed in writing this august Body on the necessity of an official authorization granted to a person to receive the check or money for funding for the construction of Bantay Dagat patrol boat from the National Agricultural and Fishery Council;

WHEREAS, this august Body, through the representation of Kagawad Gregorio A. Yrastorza, Jr., Vice Chairman, Committee on Natural Resources, has acquired knowledge that the application for the procurement of Bantay Dagat patrol boat has been approved by the Department of Agriculture, (only the processing of papers, however, is delayed for obvious reason), that the total amount as approved is P54,000.00 (instead of P70,000.00 as requested, (the VHF radio with estimated cost of P16,000.00 being disallowed)), with the following breakdown:


