RESOLUTION NO

A RESOLUTION URGENTLY REQUESTING THE HONORABLE SECRETARY, DEPARTMENT OF LABOR AND EMPLOYMENT, TO UMEDIATELY RESOLVE THE ONGOING STRIKE BY THE LEYECO V EMPLOYEES UNION AGAINST THE MANAGEMENT OF SAID FIRM IN ORMOC CITY

to a labor dispute between management and labor of WHEREAS, due LEYECO V, this city, an ongoing strike has been staged by its employees who are members of LEYECO V Employees Union, an affiliate Associated Labor Union

the said strike which has started in the later part of June 1991 yet, has taused a lot of inconveniences to a great number of people not only in Ormoc City but also in the neighboring municipalities due to frequent pownouts thereby hindering the normalcy of operation in many commercial and business establishments and causing damages to household appliances in many residential buildings and homes;

WNERZAS, Par. (g) of Art. 263 of the Labor Code of the Philippines this provide: "When in his opinion there exists a labor dispute causing or likely to cause strikes or lockouts adversely affecting the national interest, such as may occur in X X X public utilities, companies engaged in the generation or distribution of energy, X X X, the Minister of Labor and Employment shall assume jurisdiction over the decide it or certify the same to the Commission for dispute and compulsory arbitration. Such assumption or certification shall have the effect of automatically enjoining the intended or impending strike or lockout as specified in the assumption or certification order. If one has already taken place at the time of assumption or certification, all striking or locked out employees shall immediately return to work the employer shall immediately resume operations and readmit

workers under the same terms and conditions prevailing before the strike or lockout. X X X X" (Underscoring Supplied).

WHEREAS, in view of the above provisions of law and, in order to stop all resultant inconveniences to the general public due to frequent brownouts, the Honorable MEMBERS of the SANGGUNIANG PANLUMGSOD ng ORMOC, in SESSION, has considered logical and necessary to take one specific course of action;

NOW THEREFORE, on motion of Kagawad Nelson DL. Geneston, Committee on Industrial Labor, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Celso P. Porcadilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to urgently request the Honorable Secretary, Department of Labor and Employment (DOLE), Manila, to immediately resolve the ongoing strike by LEYECO V Employees against the Management of said Firm in Ormoc City

ENACTED, August 1, 1991.

RESOLVED, FURTHER, to furnish copies of this resolution each to the Honorable Secretary, Department of Labor and Management (DOLE), Intramuros, Manila, with Special Copy to Her Excellency, President Corazon C. Aquino, Malacanang, Manila, the Regional Director, DOLE, Tacloban City; Honorable Carmelo J. Locsin, Congressman, 4th District - Leyte; Honorable Ma. Victoria L. Locsin, City mayor, Ormoc City; the Acting General Manager, Leyeop V, Ormoc City; President, LEYECO V Employees Union, Ormoc City; all the Honorable Mayors of neighboring Municipalities affected by brownouts of LEYECO V, and all others concerned, - all in Ormoc City;
