RESOLUTION NO. 92

A RESOLUTION APPROVING BARANGAY ORDINANCES NO. 1 AND 3 OF BARANGAY R. M. TAN, ORMOC CITY, IMPOSING STRONGER SANCTIONS TO PERSON/S WHO MAY CAUSE DISRUPTIONS TO BARANGAY SOCIAL CELEBRATIONS, MEETING OR PUBLIC ASSEMBLIES AND PROHIBIT ALL OWNERS OR CARETAKERS OF DOMESTIC ANIMALS AND FOWLS FROM LETTING THEM STRAY OR ROAM AROUND THE BARANGAY, RESPECTIVELY.

WHEREAS, this august Body is in receipt of Barangay Ordinance No. 1 and 3 of Barangay R.M. Tan, Ormoc City which imposes stronger sanctions to person/s who may cause disruptions to Barangay Social Celebrations, Meetings or public assemblies and prohibit all owners or caretakers of Domestic Animals and fowls from letting them stray or roam around the barangay, respectively;

WHEREAS, Section 2 of Ordinance No. 1 should be amended to read as follows: "Persons caught violating this Ordinance shall upon conviction be fined THREE HUNDRED PESOS (P300.00) or an imprisonment of not more than fifteen days";

WHEREAS, this august Body conforms to the propriety and embodiment of said ordinances since it is within the ambit of the powers of the Sangguniang Barangay;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, jointly seconded by mga Kagawad Rodolfo L. Rivilla, Jr. and Edgar Z. Palugod for Barangay Ordinance No. 1 and Nelson DL. Geneston for Barangay Ordinance No. 3, respectively, be it;


RESOLVED, AS IT IS HEREBY RESOLVED, to approved Barangay Ordinances No. 1 and 3 of Barangay R. M. TAN, Ormoc City.
