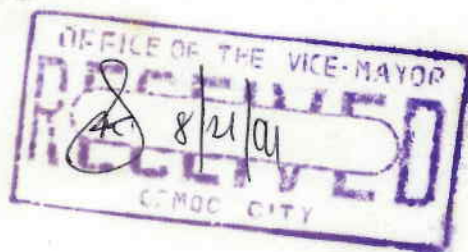
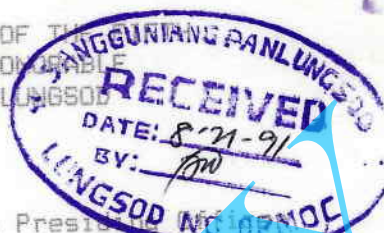

RESOLUTION NO. 93

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR OF ORMOC TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT, AS DONEE, A DEED OF DONATION WITH H. SERAFICA AND SONS CORPORATION REPRESENTED BY ITS PRESIDENT, MRS. JOSEFA S. SERAFICA, AS DONOR, A PARCEL OF LAND CONTAINING AN AREA OF TEN THOUSAND (10,000) SQUARE METERS LOCATED AT BARANGAY HERMINIGILDO SERAFICA, ORMOC CITY.

WHEREAS, this August Body is in receipt of a Deed of Donation executed by H. SERAFICA AND SONS CORP., represented by its President, MRS. JOSEFA S. SERAFICA, and for the City of Ormoc, represented by HER HONOR and CITY MAYOR MA. VICTORIA L. LOCSIN, said donation is a parcel of land containing an area of ten thousand square meters and is located at Barangay Dr. Herminigildo Serafica, Ormoc City;

WHEREAS, the purpose of said donation is for a barangay site and or a school site which this August body firmly believes that said donation will redound to the benefit of our fellow Ormocanons especially those who are living in the aforementioned barangay or in its neighboring areas considering that a School will be built which will give the youth the much needed education;




