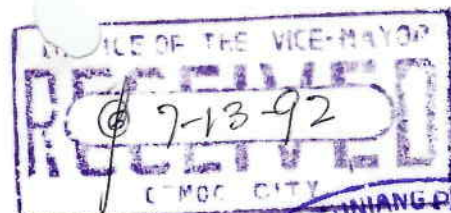

RESOLUTION NO. 07

A RESOLUTION ORGANIZING THE STANDING COMMITTEES OF THE SIXTH
SANGGUNIANG PANLUNGSOD NG ORMOC AND DESIGNATING
MEMBERSHIPS THEREOF.
