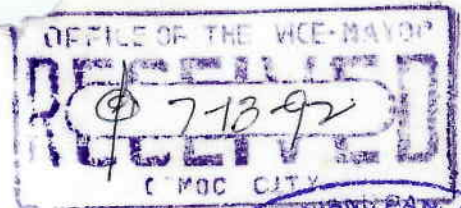

RESOLUTION NO. 08

A RESOLUTION REAPPORTIONING ORMOC CITY INTO ELEVEN (11)
REPRESENTATIVE DISTRICTS AND DESIGNATING A KAGAWAD-IN-
CHARGE FOR EVERY DISTRICT.

WHEREAS, it is incumbent upon the Vice-Mayor & Presiding Officer
and the Mga Kagawad of this august Body foremost and above all to serve
the best interest of the majority of our constituents of Ormoc City;

WHEREAS, as mandated by the people, the stupendous task that this
august Body embarks upon demands for its success every ounce of its
energy and the spirit of dedicated service;

WHEREAS, at a momentum period like this, it behooves every member
of this august Body to do his share in the great efforts of city
development and serving the people;

WHEREAS, after a thoughtful deliberation and meticulous study, in
order that the people of Ormoc can be earnestly and sufficiently served,
it has become imperative to divide Ormoc City into eleven (11)
representative districts and to apportion said districts among the
Honorable Vice-Mayor & Presiding Officer and the Honorable Mga Kagawad
of the Sixth Sangguniang Panlungsod ng Ormoc;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., jointly
seconded by mga Kagawad Benjamin B. Lladoc and Alfredo F. Capahi; be it

RESOLVED, to divide Ormoc City into eleven (11) Representative
