RESOLUTION NO. 10

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO EXTEND
THE DEADLINE FOR REGISTRATION/RENEWAL OF PERMITS/LICENSING
OF BUSINESSES FROM JANUARY 20 TO FEBRUARY 28, 1992.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of a letter from the Ormoc Filipino Retailers Association dated 14 January 1992, addressed Her Honor, the City Mayor and, the latter having endorsed the same to this august Body for appropriate action, said letter having requested for extension of the Deadline for Registration/Renewal of Permits/Licensing of Business from January 20 to February 28, 1992, alleging therein the tight financial situation being encountered by members of the association as an aftermath of typhoon Uring, with the difficulties in raising funds for payment of taxes. Also, the same letter has requested leniency in the inspection of motorcab operators' vehicles, for almost all of these vehicles have suffered damages out of the typhoon;

WHEREAS, in view of the aforementioned requests, this august Body has considered reasonable to temporarily suspend the operation of Section 1.2.1.4 of tax Ordinance No. 1 s. 1976, otherwise known as the "Ormoc City Revenue Code of 1977", fixing the first twenty (20) days of January to pay tax obligations to the government, to provide not only the members of the aforementioned retailers association, but also all taxpayers with ample time to meet the various requirements relative tax obligations. AND, to advise the agencies concerned for temporary leniency in the inspection of motorcab operators' vehicles;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Edgar Z. Palugod and Celso P. Porcadilla; be it


