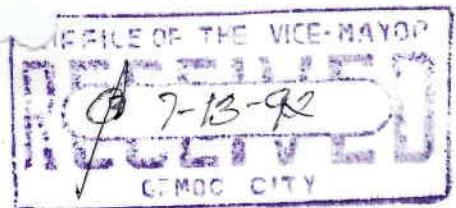

RESOLUTION NO. 10

A RESOLUTION DIRECTING THE SUPPLY OFFICER, THIS CITY, TO  
REQUIRE GOVERNMENT OFFICIALS OR EMPLOYEES WHO ARE NO  
LONGER CONNECTED WITH THE GOVERNMENT SERVICE TO RETURN  
AND/OR SETTLE WHATEVER PROPERTIES AND ACCOUNTABILITIES  
THEY HAVE YET TO RETURN OR SETTLE.

WHEREAS, it is an obligation for government officials or employees  
to settle whatever accountabilities and/or to return to the proper  
personnel in-charge whatever government properties issued to them during  
their term of office once said government officials or employees are no  
longer connected with the government service;

WHEREAS, based on reliable sources, there are some government  
officials or employees who, despite the fact of their being separated  
from the government service, still have not settled their  
accountabilities or return some properties issued to them;

WHEREAS, to protect the interest of the government, it is an  
inherent duty on whosoever is in-charge in the custody of said  
properties or accountabilities to recall and/or require these government  
officials or employees concerned to return or settle whatever properties  
and accountabilities these officials or employees may have in them and  
have failed to return or settle;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., duly  
seconded by Kagawad Alfredo F. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to direct the Supply Officer of  
this city to require government officials or employees who are no longer  
connected with the government service to return and/or settle whatever  
properties and accountabilities they have yet to return or settle;


