RESOLUTION NO. 11

A RESOLUTION EARNESTLY REQUESTING THE NATIONAL IRRIGATION
ADMINISTRATION (NIA) FOR THE DONATION OF THE EXISTING
IRRIGATION SERVICE ROADS TO THE CITY GOVERNMENT FOR THE
CITY TO MAINTAIN/REHABILITATE THE SAME.

WHEREAS according to reliable sources, the Bao River Irrigation
System (Bao RIS) Service Roads are primarily intended for the operation
and maintenance of irrigation facilities, for they serve as roads for
the transport of NIA personnel and vehicles in the operation and
maintenance of various irrigation facilities;

WHEREAS, residents and transport vehicles on certain barangays
which are without roads for the transport of farm produce to the market,
have utilized these irrigation service roads for the past few years up
to now, which because of the increased volume of traffic on these roads
has contributed much to the deterioration of these roads considering
also that NIA had not been budgeted sufficient funds for the maintenance
of these roads.

WHEREAS, many barangay officials and residents of these barangays
have requested the City Government to improve the conditions of these
roads;

WHEREAS, the City Government, in line with its continuing Program
of Services to the constituents, officially presents its accommodation
and willingness to maintain and/or rehabilitate these irrigation service
roads, provided these will be donated by NIA to the City Government
specifically on the following roads:
