RESOLUTION NO. 14

A RESOLUTION EARNESTLY REQUESTING THE COMMISSION ON  
ELECTIONS (COMELEC) TO EXEMPT THE REHABILITATION PROJECTS  
IN ORMOC CITY FROM THE ELECTION BAN.

WHEREAS, Ormoc City is believed the only principal place much  
heavily damaged by typhoon Uring last November 5, 1991, leaving  
thousands of deaths, another thousands of people missing and injuries to  
another thousands, bringing along catastrophic ruins to properties and  
infrastructures and rendering so many Ormocanons homeless and refugees;

WHEREAS, the City Government is so engrossed with its tasks and  
projects on rehabilitating the city and its typhoon-victims-people from  
monstrous ruins to a usually peaceful and beautiful City of Ormoc;

WHEREAS, the Honorable Members of the Sangguniang Panlungsod, in  
SESSION, fully believes that time element is much of the essence in  
order to fully materialize these much needed rehabilitation projects;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr.,  
Chairman, Committee on Infrastructures and concurrent Executive Officer,  
City Disaster Coordinating Council, jointly seconded by mga Kagawad  
Sixto T. Pongos and Arnulfo C. Salazar; be it


