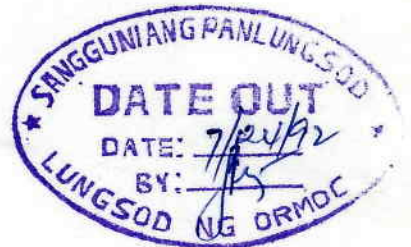

A RESOLUTION DISAPPROVING BARANGAY TAX ORDINANCE NO. 03 S.
1992 OF THE BARANGAY COUNCIL OF CABULIHAN, THIS CITY,
ENTITLED, "AN ORDINANCE IMPOSING TAX OBLIGATIONS BY
TAXPAYERS UNDER P.D. 231.

WHEREAS, this august Body is in receipt of Resolution No. 10 s.
1992 embodying Brgy. Tax Ordinance No. 03 of the Barangay Council of
Brgy. Cabulihan, this city, entitled, "AN ORDINANCE IMPOSING TAX
OBLIGATION BY TAXPAYERS UNDER P.D. 231;

WHEREAS, through the representation of the Honorable Chairman,
Committee on Laws and Ordinances, this august Body does not conform to
the propriety and embodiment of said ordinance on the ground that said
authority granted under P.D. 231 is repealed by the New Local Government
Code and the provisions of the said ordinance violate the Constitutional
provisions regarding Freedom of Speech;
