RESOLUTION NO. 19

A RESOLUTION EARNESTLY REQUESTING HONORABLE MARIANO E. BENEDICTO III, COMMISSIONER, NATIONAL TELECOMMUNICATION COMMISSION, QUEZON CITY, TO INTERCEDE IN BEHALF OF ORMOC CITY RELATIVE TO THE PROBLEMS ON TELECOMMUNICATION SYSTEM OF ORMOC, OR, TO SEND A TEAM TO EVALUATE THE SAID COMMUNICATION SYSTEM, MOST ESPECIALLY ON TELEPHONE LINES, ITS SERVICES, OPERATIONS AND EFFICIENCY AND, IF POSSIBLE, TO ALLOW OTHER TELEPHONE COMPANIES TO OPERATE IN SAID CITY.

WHEREAS, many residential and commercial establishments in Ormoc City have for long been complaining of the poor servicing and maintenance of the telecommunication system of Ormoc;

WHEREAS, it has been for 7 to 8 months that a Congressional Hearing on Communications had taken place in Ormoc City wherein, among others, all the telecommunication problems in Ormoc City were presented and discussed and, lately, according to a Representative from the National Telecommunication Commission, the result of said congressional hearing are about ready for implementation, hence a follow-up communication is imperative;

WHEREAS, last November 5, 1991, typhoon Uring mercilessly unleashed her catastrophic fury in Ormoc with untold deaths and miseries to its populace and monstrous damages to properties and, up to now, although telephone lines are reconnected or restored in some residential and business establishments yet the process is turtle or snail pace, very slow pace;

WHEREAS, in the light of the rehabilitation that the city is currently undergoing and of the possible progress that it entails thereafter, this delayed procedure on reconnections of telephone lines, its poor servicing, etcetera, warrant the possibility on allowing other telephone companies to operate in Ormoc City;

NOW, THEREFORE, on motion of Kagawad Rodolfo L. Rivilla, Jr., Chairman, Committee on Transportation & Communications, duly seconded by Kagawad Eufrocino C. Codilla, Jr., be it


RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request Honorable Mariano E. Benedicto III, Commissioner, National Telecommunication Commission, Quezon City, to intercede in behalf of Ormoc City relative to the problems on telecommunication system of Ormoc, or, to send a team to evaluate the said communications system, most especially on telephone lines, its services, operations and efficiency and, if possible, to allow other telephone companies to operate in said city;

ENACTED, January 30, 1992.

RESOLVED, FURTHER, to furnish copies of this resolution one each to Honorable Mariano E. Benedicto III, Commissioner, National Telecommunication Commission, Quezon City; Honorable Congressman Edward M. Matti, Chairman, Committee on Transportation & Communications, House of Representatives - CONGRESS, Quezon City; Honorable Josefina Lichauco, Undersecretary, Department of Transportation & Communications, Manila; Honorable Congressman Carmelo J. Locsin, Congressman, 4th District-Leyte; Honorable Ma. Victoria L. Locsin, City Mayor, Ormoc City, and all others concerned in Ormoc City;


