RESOLUTION NO. 19

A RESOLUTION HIGHLY REQUESTING DIRECTOR GENERAL CESAR P. NAZARENO, PHILIPPINE NATIONAL POLICE (PMP), CAMP CRAME, QUEZON CITY, FOR ASSIGNMENT OF AT LEAST FIFTY (50) ADDITIONAL POLICEMEN IN ORMOC CITY.

WHEREAS, the Chief Inspector of Ormoc-PNP, through a letter dated 16 July 1992, has requested the Honorable City Mayor of Ormoc for an additional of at least fifty (50) policemen to cope up criminalities and vices of the city with a population of 150,000 people, more or less, based on an authorized strength of one (1) policeman for every 1,000 of the city population;

WHEREAS, the aforesaid letter has further stated that the Ormoc Police Department has currently depleted of personnel, with only eighty five (85) police officers and men as their present organic strength, some are even assigned or detailed in other agencies of the government;
