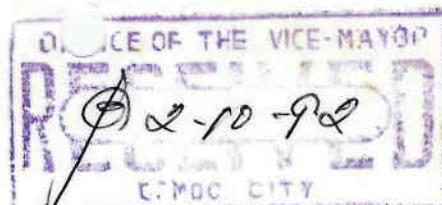

RESOLUTION NO. 20

A RESOLUTION APPROVING THE ORDINANCES, ALL IN CURRENT YEAR  
SERIES, AS SUBMITTED BY SOME THIRTEEN DIFFERENT BARANGAY  
COUNCILS IN ORMOC CITY, ALL PERTAINING TO PRESCRIBING  
RATES OF FEES AND CHARGES ON BARANGAY CLEARANCES  
CORRESPONDINGLY ISSUED FOR SPECIFIC PURPOSES AND FOR OTHER  
PURPOSES.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of the  
Ordinances, all series of 1992, one each from thirteen (13) different  
Barangay Councils in Ormoc City, all pertaining to prescribing rates of  
fees and charges on barangay clearances issued for specific purposes and  
for other purposes;

WHEREAS, this august Body has observed that the provisions of the  
different ordinances as submitted are substantially identical,  
reasonable and within the powers of Barangay Councils to legislate;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman,  
Committee on Laws and Ordinances, jointly seconded by mga Kagawad Nelson  
DL Geneston and Celso P. Porcadilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Ordinances, all

Barangay Councils in Ormoc City, all pertaining to Prescribing Rates of
