RESOLUTION NO. 21

A RESOLUTION DISAPPROVING ORDINANCE NO. 2 5. 1992 OF THE SANGGUNIANG BARANGAY OF COGON, THIS CITY, "ISSUANCE OF COMMUNITY TAX IN THE BARANGAY AS REQUIRED UNDER THE 1991 LOCAL GOVERNMENT CODE".

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of Ordinance No. 2 s. 1992 from the Barangay Council of Cogon, this city, entitled, "Issuance of Community Tax in the barangay as required under the 1991 Local Government Code";

WHEREAS, although the intention in the levying of Community Tax may be good, nevertheless, in the light of the provision of Section 156 of the Local Government Code, it is not within the powers and prerogatives of a Barangay Council to levy and collect Community Taxes;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws & Ordinances, duly seconded by Kagawad Gregorio A. Yrastorza, Jr., be it

RESOLVED, to pass a resolution DISAPPROVING ORDINANCE NO. 2 S. 1992 OF THE SANGGUNIANG BARANGAY OF COGON, THIS CITY, ENTITLED, "ISSUANCE OF COMPUNITY TAX IN THE BARANGAY AS REQUIRED UNDER THE 1991 LOCAL GOVERNMENT CODE";
