RESOLUTION NO. 21

WHEREAS, this august Body bears the shock with which it takes the news of the sudden death of a highly esteemed former City Councilor ASUNCION C. OMEGA of the Municipal Board of Ormoc City who succumbed last July 7, 1992 in the state of New Jersey, U.S.A.;

WHEREAS, the late Honorable ASUNCION C. OMEGA, a bonafide resident of Ormoc City, had dedicated the best years of her life to the Ormocanons for whose common weal had been her primordial concern, a hardworking woman whose principal aim was to serve her fellowmen; "CONCHING", as she was fondly called by friends in Ormoc City, had greatly helped bring Ormoc to its present status of a financially stable, peaceful and beautiful city;

WHEREAS, reckoning back to her service in the government, she had served for one (1) year, seven (7) months and twelve (12) days, from 26 August 1960 to March 8, 1962, as an elected City Councilor of the Municipal Board of Ormoc, which, although quite a short period, nevertheless, she was then endeared and loved by the Ormocanons;

WHEREAS, the Honorable MEMBERS of the Sixth SANGGUNIANG PANLUNGSOD ng ORMOC, having greatly felt the irreparable loss of a conscientious and peace loving city legislator and friend, in SESSION, shares the intense pain and sorrow with her children Fe, Flor, Feodore and Ferdinand, as well as the anguish and despair with grandchildren and relatives of the late Asuncion C. Omega for the passing away of a carressing, dutiful and affectionate mother and accomodating kin who had dedicated her life in the service of her community and country and could have been more in service thereto were she to live longer through the years;

NOW, THEREFORE, on a motion presented by Kagawad Sotero M. Pepito, UNANIMOUSLY SECONDED by all other mga Kagawad present; be it

RESOLVED, to express our MOST PROFOUND SYMPATHY by way of this RESOLUTION OF CONDOLENCE TO THE BEREAVED FAMILY AND CLAN OF THE LATE CITY COUNCILOR ASUNCION C. OMEGA OF THE MUNICIPAL BOARD OF ORMOC CITY for her untimely demise and, do, this Body hereby does, join in mourning with the family and clan of the deceased in this, their hour of bereavement;


