RESOLUTION NO. 22

A RESOLUTION APPROVING THE ORDINANCES, ALL IN CURRENT YEAR SERIES, SUBMITTED BY FOUR (4) DIFFERENT BARANGAY COUNCILS IN ORMOC CITY, ALL PERTAINING TO PRESCRIBING RATES OF FEES AND CHARGES ON BARANGAY CLEARANCES CORRESPONDINGLY ISSUED FOR SPECIFIC PURPOSES AND FOR OTHER PURPOSES.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of the Ordinances, all series of 1992, one each from four (4) different Barangay Councils in Ormoc City, all pertaining to prescribing rates of fees and charges on barangay clearances issued for specific purposes and for other purposes;

WHEREAS, this august Body has observed that the provisions of the ordinances as submitted are substantially reasonable and within the powers of Barangay Councils to legislate;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Edgar Z. Palugod and Antero T. Fiel; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Ordinances, all in current year series, submitted by four (4) different Barangay Councils in Ormoc City, all pertaining to Prescribing Rates of Fees and Charges on Barangay Clearances correspondingly issued for specific purposes and for othr purposes;
