RESOLUTION NO. 22

A RESOLUTION APPROVING ORDINANCE NO. 3 5. 1992 OF THE BARANGAY COUNCIL OF BRGY. LINAO, ORMOC CITY, ENTITLED, " A RESOLUTION REQUIRING HEADS OF FAMILIES WHO WILL BE RELOCATED TO BARANGAY LINAO, ORMOC CITY, TO SUBMIT TO THE PUNONG BARANGAY OF BARANGAY LINAO, POLICE CLEARANCES AND HEALTH CERTIFICATES COVERING MEMBERS OF HIS/HER FAMILY FOR SECURITY AND HEALTH."

WHEREAS, this august Body is in receipt of Ordinance No. 3 s. 1992 of the Barangay Council of Brgy. Linao, this city, entitled, " A Resolution requiring Heads of the Families who will be relocated to Brgy. Linao, Ormoc City, to submit to the Punong Barangay of Brgy. Linao, Police Clearances and Health Certificates covering members of his/her family for Security and Health";

WHEREAS, the City Legal Officer, through 3rd Indorsement dated 27 July 1992, has made the following commentaries:

"There is no legal impediment as to passage or effectivity of Ordinance No. 3 s. 1992. Sec. 390 (a) (1) of the Local Sovernment Code provides:

- (a) The sangguniang barangay, as the legislative body of the barangay shall:
- "(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinances and to promote the general welfare of the inhabitants therein."

"Moreover, Sec. 16 of the same Code grants to Local government units the power " to promote the health and safety of their inhabitants."

"Finally, the age bracket (between 16 to 65 years old) persons required to secure police clearance under Sec. 1(a) of Ordinance No. 3 is justified by the fact that most crimes are committed by persons falling under this age bracket. Thus, such distinction is not violative of the equal protection law clause of the Constitution."

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, severally seconded by mga Kagawad Sotero M. Pepito, Alfredo F. Capahi, Jose C. Alfaro, Jr., be it

RESOLVED, to pass a resolution APPROVING ORDINANCE NO. 3 S. 1992 OF BARANBAY COUNCIL OF BRGY. LINAO, ORMOC CITY, ENTITLED, " A RESOLUTION REQUIRING HEADS OF FAMILIES WHO WILL BE RELOCATED TO BARANGAY LINAD, ORMOC CITY, TO SUBMIT TO THE PUNONG BARANGAY OF BRGY. LINAD, POLICE CLEARANCES AND HEALTH CERTIFICATES COVERING MEMBERS OF HIS/HER HIS/HER FAMILY FOR SECURITY AND HEALTH";
