RESOLUTION NO. 23

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ENTER INTO A NEGOTIATED CONTRACT WITH WOOLBRIGHT CORPORATION FOR THE DRILLING OF ONE (1) UNIT PRODUCTION WELL AT BARANGAY SAN PABLO, ORMOC CITY, SUBJECT TO THE REQUIREMENTS OF SAID NEGOTIATED CONTRACT.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of a letter from the Honorable City Mayor requesting for an authority to enter into a contract with Woolbright Corporation for the drilling of one (1) unit Production Well at Barangay San Pablo, this city;

WHEREAS, for emergency reasons and the fact that the constituents of said barangay are in dire-need for a potable water, (ORMOSA connections in said place had for long been in complete breakdown as one aftermath of typhoon Uring), negotiations relative to the drilling of the production well and the drilling itself are already underway, subject, however, to an authorization granted by the city legislative body;

WHEREAS, in extreme and exceptional cases, this august Body feels considerate and understands that the move, although wanting, is in line with the Program of the City Government for continuing services for the benefit of its constituents;

NOW, THEREFORE, on motion of Kagawad Gregorio A. Yrastorza, Jr., Chairman, Committee on Infrastructures, duly seconded by Kagawad Nelson DL. Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to enter into a negotiated contract with Woolbright Corporation for the drilling of one (1) unit Production Well at Barangay San Pablo, this city, subject to the requirements of said negotiated contract;



CARRIED UNANIMOUSLY.


