RESOLUTION NO. 23

A RESOLUTION EARNESTLY REQUESTING THE JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) FOR A DONATION OF THREE (3) GARBAGE TRUCKS WITH COMPACTORS AND THREE (3) DUMPTRUCKS AND AUTHORIZING THE HONORABLE CITY MAYOR TO UNDERTAKE THE NEGOTIATION FOR THIS PURPOSE.

WHEREAS, the City Government of Ormoc, in its effort to put Ormoc City back to its former status, prior to typhoon "URING" last November 5, 1991, is in dire need of three (3) garbage trucks with compactors and three (3) dumptrucks to cope up with the needs of the city on its rehabilitation programs and to facilitate the collection of garbage, thus safeguarding the health of its constituents;

WHEREAS, the Sixth Sangguniang Panlungsod ng Ormoc in SESSION has considered such request as urgent and must be given attention which this august Body firmly believes would redound to the benefit of the Ormocanons, the former equipment having been destroyed by the flood;

NOW, THEREFORE, on motion of Kagawad Jose C. Alfaro, Jr., Chairman, Committee on Transportation and Communication, jointly seconded by mga Kagawad Mariano Y. Corro, Alfredo F. Capahi, Benjamin B. Lladoc and Jose B. Conejos, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution requesting the Japan International Cooperation Agency (JICA) for a donation of three (3) garbage trucks with compactors and three (3) dump trucks and authorizing the Honorable City Mayor to undertake the negotiation for this purpose;
