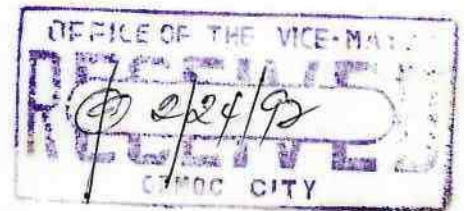

RESOLUTION NO. 24

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO GRANT
ADDITIONAL EXTENSION OF THE DEADLINE FOR
REGISTRATION/RENEWAL OF PERMITS/LICENSING OF BUSINESSES
FROM FEBRUARY 28 TO MARCH 15, 1992.

WHEREAS, through an Unnumbered Resolution, current year series, the Board of Directors - Ormoc Filipino Retailers Association has requested the Honorable City Mayor, (and reference is made to the Honorable Sangguniang Panlungsod for appropriate legislative action), for another extension of the deadline of registration/renewal of permits/licensing of businesses from February 20 to March 31, 1992, alleging therein the difficulty in raising sufficient funds for payment of taxes and the sudden increase of these taxes in line with the implementation of the Local Government Code;

WHEREAS, in view of the aforementioned request, and, notwithstanding earlier passage of Resolution No. 10 s. 1992 which had authorized the City Mayor to extend the deadline of registration/renewal of permits/licensing of businesses from January 20 to February 29, 1992, this august Body still has considered reasonable on allowing for additional extension of said deadline in order to provide not only the members of the aforementioned retailers association but also all taxpayers with ample time to meet the various tax requirements and pay their tax obligations to the government;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Eufrocino C. Codilla, Jr. and Gregorio A. Yrastorza, Jr., be it




