A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE PORTS AUTHORITY (PPA) THRU MR. ROGELIO A. DAYAN, GENERAL MANAGER PPA, SOUTH HARBOR, MANILA, TO CONSTRUCT A "PASSENGER SHED" AT THE ORMOC PORT WITHIN THE PROPERTY BELONGING TO THE PPA.

WHEREAS, the City of Ormoc has become the focal point of entry and departure of many sea travelers mostly from its neighboring cities and provinces; thi is considered as one of the reasons why said pier is under construction as requested by the City Government of Ormoc per SP Resolution No. 115 dated 19 September 1991;

WHEREAS, due to circumstances beyond control it could not be denied that in some boat passengers miss their trips or get stranded thus necessitating the need of a temporary shelter for them;

NOW THEREFORE, on motion of Kagawad Jose C. Alfaro Jr., Chairman, Committee on Transportation and Communication, jointly seconded by mga Kagawad Benjamin B. Lladoc and Alfredo F. Capahi, be it;

RESOLVED AS IT IS HEREBY RESOLVED to pass a resolution earnestly requesting the Philippine Ports Authority (PPA) thru Mr. Rogelio A. Dayan, General Manager, PPA, South Harbor Manila, to construct a "Passenger Shed" at the Ormoc Port within the property belonging to the PPA;
