## RESOLUTION NO. 25

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ISSUE CERTIFICATES OF OCCUPANCY TO RELOCATED SQUATTERS AT BARANGAY ALTA VISTA AND BAGONG BUHAY SUBJECT TO THE GUIDELINES TO BE FORMULATED BY THE TASK FORCE ON URBAN POOR AND HUMAN SETTLEMENTS, (CONSISTING OF THREE (3) LOTS IN EACH BARANGAY).

ABC President,

WHEREAS, for so long a time that the relocated squatters in the resettlement areas at Barangays Bagong Buhay and Alta Vista, this city, have been in a quandary relative to their tenure of occupancy of the land on where their houses had been constructed, considering that they do not own the land and their applications for Transfer Certificates of Titles have for long been pending and indefinitely;

these relocated settlers are truly bonafide occupants of the lots at issue in said resettlements areas, well-deserving to be entitled for something and, be relieved from the burden on seemingly frustrated longing on acquiring small parcels of land with equitable papers which they can be proud of and can humbly call their own;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Celso P. Porcadilla and Nelson DL. Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor to issue Certificates of Occupancy to relocated squatters at Barangays Alta Vista and Bagong Buhay, subject to the guidelines to be formulated by the Task Force on Urban Poor and Human Settlements, (consisting of three (3) lots in each barangay);
