RESOLUTION NO. 25

A RESOLUTION EARNESTLY REQUESTING THE PHILIPPINE PORTS
AUTHORITY, THROUGH MR. ROGELIO A. DAYAN, GENERAL MANAGER, PPA,
SOUTH HARBOR, MANILA, TO CONSTRUCT A WAREHOUSE IN THE
RECLAIMED AREA OF THE ORMOC PORT WITHIN THE PREMISES OF PPA
COMPOUND.

WHEREAS, heavy trucks hauling goods and cargoes directly from ships
and barges have added to the already congested port in Ormoc City, some
of these stocks or cargoes are even filed along the sides of the pier,
rendering clear difficulty of passage or accessibility by the commuters
to and from anchored ships;

WHEREAS, a remedy is necessary to solve or remedy this disorderly
situation at the Ormoc Port, to avoid danger to life and limbs;


