RESOLUTION NO. 26

A RESOLUTION APPROVING THE ORDINANCES, ALL IN CURRENT YEAR SERIES, SUBMITTED BY FOUR (4) DIFFERENT BARANGAY COUNCILS IN ORMOC CITY, ALL PERTAINING TO PRESCRIBING RATES OF FEES AND CHARGES ON BARANGAY CLEARANCES CORRESPONDINGLY FOR SPECIFIC PURPOSES AND FOR OTHER PURPOSES.

WHEREAS, the Hoporable Sangguniang Panlungsod is in receipt of the Ordinances, all series of 1992, one each from four (4) different Barangay Councils in Ormoc City, all pertaining to prescribing rates of fees and charges on barangay clearances issued for specific purposes and other pursposes;

this august Body has observed that the provisions of the different ordinances as submitted are substantially identical, WHEREAS, reasonable and within the powers of the Barangay Councils to legislate;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Celso P. Porcadilla, Edgar Z. Palugod and Nelson DL. Geneston (for Brgy. Dist. XXVI and Bpgy. Dolores) and mga Kagawad Antero T. Fiel, Celso P. Porcadilla and Edgar Z. Palugod (for Brgy. Nasunogan and Brgy. Airport);

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Ordinances, all in current year series, submitted by four (4) different Barangay ouncils in Ormoc City, all pertaining to Prescribing Rates of Fees and Charges on Barangay Clearances correspondingly issued for specific purposes and for other purposes;

RESOLVED, FURTHER, to state herein below the list of the four (4) Barangay Councils (with corresponding Ordinance Numbers) which had submitted the said barnagay tax ordinances, as follows:
