SOUTH HARBOR, MANILA, TO UNDERTAKE THE CONCRETING OF THE  
STORAGE AREA AT THE ORMOC PORT WITHIN THE PPA COMPOUND.

WHEREAS, the City Government of Ormoc has observed that after  
reclaiming a portion of the Ormoc City Pier and utilizing such space as  
a storage area, the PPA has not yet made any undertaking in the  
concreting of said area, making it difficult for the Fork Lifts, and  
Cargo Trucks in loading and unloading cargoes which are to be taken to  
and from the vessels and stored in the said area;

WHEREAS, the Sixth Sangguniang Panlungsod in SESSION has considered  
such request as urgent and must be given attention thereby easing the  
flow of the loading and unloading of said cargoes to and from the  
vessels and to give convenience to commuters as well;
