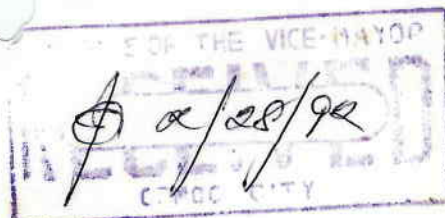

A RESOLUTION ENDORSING THE RECOMMENDATION OF THE TERMINAL  
SUPERVISOR, PHILIPPINE PORTS AUTHORITY, SUB-PORT OF ORMOC  
TO THE PORT MANAGER, PMO TACLOBAN TO GRANT THE ORMOC  
DOCKHANDLERS, INC., APPROVAL OF THEIR APPLICATION FOR  
FIVE-YEAR SERVICE CONTRACT.
