RESOLUTION NO. 29

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR MA. VICTORIA L. LOCSIN OF ORMOC CITY TO ENTER INTO A CONTRACT WITH THE BUREAU OF LOCAL GOVERNMENT FINANCE OF THE DEPARTMENT OF FINANCE, THROUGH THE REAL PROPERTY TAX ADMINISTRATION - REGIONAL PROJECT MANAGEMENT OFFICE (RPTA - RPMO), REGION VIII, TACLOBAN CITY, RELATIVE TO THE PROGRAM GRANT AGREEMENT BETWEEN THE UNITED STATES AGENCY FOR INTERNATIONAL DEVELOPMENT (USAID) AND THE PHILIPPINE GOVERNMENT, AND TO REQUEST FOR AN APPROPRIATION OF ₱510,500.00 REPRESENTING 40% (LOCAL COUNTERPART) OF THE PROJECT COST OF ₱1,276,250.00.


