RESOLUTION NO. 29

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR MA. VICTORIA L. LOCSIN OF ORMOC CITY TO ENTER INTO A CONTRACT WITH THE BUREAU OF LOCAL GOVERNMENT FINANCE OF THE DEPARTMENT OF FINANCE, THROUGH THE REAL PROPERTY TAX ADMINISTRATION - REGIONAL PROJECT MANAGEMENT OFFICE (RPTA - RPMO), REGION VIII, TACLOBAN CITY, RELATIVE TO THE PROGRAM GRANT AGREEMENT BETWEEN THE UNITED STATES AGENCY FOR INTERNATIONAL DEVELOPMENT (USAID) AND THE PHILIPPINE GOVERNMENT, AND TO REQUEST FOR AN APPROPRIATION OF P510,500,00 REPRESENTING 40% (LOCAL COUNTERPART) OF PROJECT COST OF \$1,276,250.00.

Region VINI, Tacloban City, relative to the Program Grant Agreement between the United States Agency for International Development (USAID) and the Philippine Government, and to request for an appropriation of \$\mathbf{P}\$510,500.00 40% (local counterpart) of the project cost of representing F1,276,250.00;
