## RESOLUTION NO. 30

A RESOLUTION APPROVING THE ORDINANCES, ALL IN CURRENT YEAR SERIES, SUBMITTED BY BARANGAY COUNCILS OF MAHAYAG AND DISTRICT 27 OF ORMOC CITY, BOTH PERTAINING TO PRESCRIBING OF FEES AND CHARGES ON BARANGAY CORRESPONDINGLY ISSUED FOR SPECIFIC PURPOSES AND FOR OTHER PURPOSES, TOGETHER WITH AN AMENDATORY ORDINANCE NO. 92-1 S. 1992 ON FINES FOR UNEXCUSED ABSENCES OF BARANGAY DISTRICT 27.

WHEREAS, the Honorable Sangguniang Panlungsod is in receipt of the Ordinances, all series of 1992, from Barangay Distrcit 27 and Barangay Mahayag, both in Ormoc City, pertaining to prescribing rates of fees and charges on barangay clearances issued for specific purposes and other purposes, together with an amendatory Ordinance No. 92-1 s. 1992 on fines for unexcused absences from Barangay District 27;

WHEREAS, this august Body has observed that as regards the rates of fees and charges on barangay clearances, the provision of said ordinances, as submitted, are substantially identical, reasonable and within the powers of the Barangay Councils to legislate, including amendment, if necessary, relative to fines on unexcused absences of Barangay District 27;

NOW, THEREFORE, on motion of Kagawad Benjamin F. Tugonon, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Celso P. Forcadilla and Nelson DL. Geneston (for Brgy. Mahayag), and Kagawad Gregorio A. Yrastorza, Jr. (Brgy. District 27); be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the Ordinances, in current year series, submitted by Barangay Councils of Mahayag and District 27 of Ormoc City, both pertaining to Prescribing Rates of Fees and Charges on Barangay Clearances correspondingly issued for specific purposes and other purposes, together with an amendatory Ordinance No. 92-1 s. 1992 on Fines for Unexcused Absences of Barangay District 27;
