

RESOLUTION NO. 31

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, AS DONEE, A DEED OF DONATION EXECUTED BY SPOUSES JORGE GALVEZ AND ENCARNACION ALAURA-GALVEZ ON A PARCEL OF LAND WITH AN AREA OF 1,267 SQUARE METERS KNOWN AS LOT 5342-1, SITUATED AT BARANGAY BAGONG BUHAY, ORMOC CITY.

WHEREAS, this august Body is in receipt of a Deed of Donation executed by spouses JORGE GALVEZ and ENCARNACION ALAURA-GALVEZ on a parcel of land containing an area of 1,267 sq. m., known as Lot 5342-1 situated at Barangay Bagong Buhay, Ormoc City;

WHEREAS, said donation is made out of the donors' civic spiritedness and generosity to help the city government find a way to push through with its road-right-of-way plans or programs;


