RESOLUTION NO. 32

A RESOLUTION AUTHORIZING THE CITY TREASURER TO EFFECT AN INTER-FUND TRANSFER IN THE AMOUNT OF 7310,529.80 FROM THE UNAPPROPRIATED SURPLUS OF THE GENERAL FUND TO THE INFRASTRUCTURE PUND FOR THE 1991 PRODUCTIVITY INCENTIVE BONUS OF THE CITY GOVERNMENT OFFICIALS AND EMPLOYEES UNDER THE INFRASTRUCTURE FUND.

WHEREAS, this august Body is in receipt of an indorsement from the OIC of City Budget Office requesting to authorize the City Treasurer to make an interfund transfer in the amount of \$7310,529.80 from the Unappropriated Surplus of the General Fund to Infrastructure Fund to be utilized for payment of the 1991 Productivity Incentive Bonus of City Government personnel under the Infrastructure Fund;

MHEREAS, an interfund transfer is authorized under the Budget Operation Manual for Local Governments, specifically Section 3.19 (4) thereof;

NOW, THEREFORE, on motion of Kagawad Sixto T. Pongos, Chairman, Committee on Finance, jointly seconded by mga Kagawad Gregorio A. Yrastorza, Jr. and Nelson DL. Geneston; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the City Treasurer to effect an Inter-Fund Transfer in the amount of P310,529.80 from the Unappropriated Surplus of the General Fund to the Infrastructure Fund for the 1991 Productivity Incentive Bonus of the City Government officials and employees under the Infrastructure Fund;
