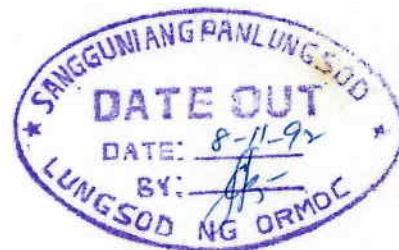

A RESOLUTION REQUESTING THE GENERAL MANAGER, LEYECO V TO
INSTALL A 3-PHASE POWER LINE TO THE NEW DEEP WELL AT
BARANGAY ALTA VISTA, ORMOC CITY.

WHEREAS, the production well (Deep Well) which was installed at
Barangay Alta Vista, this city as authorized per S. P. Resolution No.
44 dated 19 March 1992 is already completed but for it to be
operational, it needs a 3-phase power line to enable the pump to
function;

WHEREAS, the Sixth Sangguniang Panlungsod in SESSION has considered
such need as urgent and must be given attention in line with the Program
of the City Government for continuing services for the benefit of its
constituents;

NOW, THEREFORE, on motion of Kagawad Nestor C. Penserga, jointly

P. Larrazabal and Alfredo F. Capahi, be it
