WHEREAS, the production well (Deep well) which was installed at
Barangay Alta Vista, this city as authorized per S.P. Resolution No. 44
dated 19 March 1992 is already completed and in order to serve its
purpose, a pipeline is needed to allow the water from the reservoir to
flow-in going to the Barangay Proper;

WHEREAS, the Sixth Sangguniang Panlungsod in SESSION has considered
such need as urgent and must be given attention in line with the Program
of the City Government for continuing services for the benefit of its
constituents;

Alfredo F. Capahi, be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution requesting
