RESOLUTION NO. 34

A RESOLUTION RESPECTFULLY REQUESTING THE HONORABLE MAYOR  
EUFROCINO M. CODILLA, SR., CITY MAYOR OF ORMOC, TO  
NEGOTIATE WITH THE DEPARTMENT OF INTERIOR AND LOCAL  
GOVERNMENT (DILG) FOR THE ALLOCATION OF TWO (2) FIRE  
TRUCKS WITH 10,000 LITERS CAPACITY FOR ORMOC CITY.

WHEREAS, besides insufficiency of fire trucks to fight  
conflagration and other occurrences which demand for immediate action or  
coordination of the Ormoc Fire Department, the area of responsibilities  
of said fire department has been broaden due to many relocation sites  
made for the flood victims of typhoon Uring;

WHEREAS, through the representation of the Honorable Chairman,  
Committee on Police, Fire & Public Safety, this august Body has become  
knowledgeable that the Department of Interior and Local Government (or  
DILG) has been a recipient of a good number of fire trucks donated by  
Japan International Cooperation Agency (JICA) for distribution to  
different LGUs;

NOW, THEREFORE, on a motion presented by Kagawad Jose C. Alfaro,  
Jr., Chairman, Committee on Police, Fire & Public Safety, severally  
seconded by mga Kagawad Celso P. Adolfo, Sotero M. Pepito and Alfredo F.

RESOLVED, AS IT IS HEREBY RESOLVED, to respectfully request the  
Honorable Mayor Eufrocino M. Codilla, Sr., City Mayor of Ormoc, to  
negotiate with the Department of Interior and Local Government (DILG)  
for the allocation of two (2) Fire Trucks with 10,000 liters capacity  
for Ormoc City;


