RESOLUTION NO. 37

A RESOLUTION APPROVING THE ORDINANCES, ALL IN CURRENT YEAR SERIES, SUBMITTED BY THREE (3) DIFFERENT BARANGAY COUNCILS IN ORMOC CITY, ALL PERTAINING TO PRESCRIBING RATES OF FEES AND CHARGES ON BARANGAY CLEARANCES CORRESPONDINGLY ISSUED FOR SPECIFIC PURPOSES AND FOR OTHER PURPOSES.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of the Ordinances all series of 1992, one each from three (3) different Barangay Councils in Ormoc Eity, all pertaining to prescribing rates of fees and charges on barangay clearances issued for specific purposes and other pursposes;

WHEREAS, this august Body has observed that the provisions of the erent ordinances, as submitted, are substantially identical, reasonable and within the powers of the Barangay Councils to legislate;
