RESOLUTION NO. 39

A RESOLUTION CREATING THE PEOPLE'S LAW ENFORCEMENT BOARD
(PLEB) IN ORMOC CITY AND NOMINATING ONE MEMBER OF THE
SANGGUNIANG PANLUNGSOD AS A MEMBER THEREOF.

WHEREAS, Section 43 of Republic Act 6975 pertains to establishing
the Philippine National Police (PNP) under the reorganized Department of
Interior and Local Government or DILG;

WHEREAS, in pursuance to said Republic Act, the City Government of
Ormoc avails for the creation of the People's Law Enforcement Board
(PLEB), tasked to receive and decide citizens' complaints against erring
officers and members of the Philippine National Police within the
jurisdiction of Ormoc City;

WHEREAS, under the law, once a complaint is filed before the Board
and after due hearing, the PLEB by majority votes of all its members and
its chairman shall determine whether or not the respondent officer or
member of the Philippine National Police is guilty of the charge upon
which the complaint is based and shall render its decision within sixty
(60) days from the time the case is filed;

WHEREAS, the fact that the Honorable Members of the Sangguniang
Panlungsod ng Ormoc are official representatives of the constituents in
Ormoc City, through the representation of the Honorable Chairman,
Committee on Good Government, Ethics & Human Rights, this august Body
has nominated and officially endorsed a Member in the person of the
Honorable Kagawad Jose C. Alfaro, Jr. to be one of the Members of PLEB;

NOW, THEREFORE, on motion of Kagawad Sotero M. Pepito, Chairman,
Committee on Good Government, Ethics & Human Rights, duly seconded by
Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution CREATING THE PEOPLE'S LAW
ENFORCEMENT BOARD (PLEB) IN ORMOC CITY AND NOMINATING ONE MEMBER OF THE
SANGGUNIANG PANLUNGSOD AS A MEMBER THEREOF;


