RESOLUTION NO. 4

A RESOLUTION THANKING THE HONORABLE SANGGUNIAN NG PANLALAWIGAN NG BOHOL, TAGBILARAN, BOHOL, FOR THE FINANCIAL ASSISTANCE EXTENDED TO THE VICTIMS OF TYPHOON URING IN ORMOC CITY, LEYTE, THROUGH THE PROVINCIAL DISASTER COORDINATING COUNCIL OF LEYTE PROVINCE.

WHEREAS, this august Body is in receipt of Resolution No. 316 s. 1991 from the Honorable Sangguniang Panlalawigan ng Bohol, entitled, "A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE VICTIMS OF TYPHOON URING IN ORMOC CITY, LEYTE THROUGH THE PROVINCIAL AND COORDINATING COUNCIL OF THE SAID PROVINCE";
