RESOLUTION NO. 41

A RESOLUTION EARNESTLY REQUESTING THE ABOITIZ SHIPPING CORPORATION FOR ADDITIONAL PASSENGER VESSELS FOR THE ORmoc - CEBU - CEBU - ORmoc ROUTE AS SOON AS POSSIBLE AFTER THE REHABILITATION WORK IS OVER AT THE ORmoc CITY PIER.

WHEREAS, the City of Ormoc has become the focal point of entry and departure of many sea travelers mostly from its neighboring cities and provinces, one of the reasons why Ormoc pier is under construction as requested by the City Government per SP Resolution No. 115 dated September 1991;

WHEREAS, in view of the increasing number of sea commuters, the City Government of Ormoc has observed that a need for additional passenger vessels is necessary to cope up with such problem so that by the time the rehabilitation work at the city pier is over, convenience can be obtained not only on the part of the sea commuters but to the vessels as well;

NOW, THEREFORE, on motion of Kagawad Jose B. Conejos, Vice-Chairman, Committee on Transportation and Communications jointly seconded by mga Kagawad Sotero M. Pepito and Jose C. Alfaro, Jr., be it

RESOLVED, AS IT IS HEREBY RESOLVED, to earnestly request the Aboitiz Shipping Corporation for additional passenger vessels for the Ormoc-Cebu-Cebu-Ormoc route as soon as possible after the rehabilitation work is over at the Ormoc City pier;


