RESOLUTION NO. 43

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT, A DEED OF DONATION COVERING LOT 878-PART (BEING A PORTION OF LOT 878, ORMOC CADASTRE) SITUATED AT SAN PABLO ST., ORMOC CITY, WITH AN AREA OF 500 SQUARE METERS IN FAVOR OF THE PHILIPPINE NATIONAL RED CROSS, ORMOC CHAPTER, PROVIDED THAT THE LATTER SHOULD RETURN THE LOT AND ALL IMPROVEMENTS THEREOF IF THE SAME WOULD NO LONGER BE USED.

WHEREAS, the Honorable Sangguniang Panlungsod ng Ormoc is in receipt of a Board Resolution from the Philippine National Red Cross, Ormoc Chapter, entitled, "A RESOLUTION REQUESTING THE CITY THRU MAYOR MA. VICTORIA L. LOCSIN FOR A LOT DONATION FOR THE CHAPTER";

WHEREAS, the City Government has recommended that lot 878-Part (being a portion of lot 878, Ormoc Cadastre) situated at San Pablo Street, Ormoc City, with an area of 500 sq. m. be donated to the Philippine National Red Cross, Ormoc Chapter;

WHEREAS, this august Body has considered reasonable on providing the Philippine National Red Cross - Ormoc Chapter with a site on where to have their building or nucleus in the discharge of humanitarian works and services most particularly to the poor and the needy, subject, however, that the donated land be returned to the City Government if no longer needed by the said entity;

NOW, THEREFORE, on motion of Kagawad Arnulfo C. Salazar, Chairman, Committee on Public Properties, duly seconded by Kagawad Celso P. Porcadilla; be it

RESOLVED, AS IT IS HEREY RESOLVED, to authorize the Honorable City Mayor to sign, for and in behalf of the City Government, a Deed of Donation covering lot 878 - Part (being a portion of lot 878, Ormoc


Cadastre) situated at San Pablo Street, this city, with an area of 500 sq. m. in favor of the Philippine National Red Cross, Ormoc Chapter, provided that the latter should return the lot and all improvements thereof if the same would no longer be used;

ENACTED, March 19, 1992.

RESOLVED, FURTHER, to furnish copies of this resolution each to Her Honor, the City Mayor, the City Treasurer, the Registrar - Register of Deeds, the City Engineer, the City Legal Officer and the Secretary - Philippine National Red Cross, Ormoc Chapter, -all in Ormoc City.
